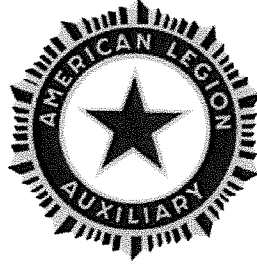


**Whereas**, the American Legion Auxiliary, Department of Alaska wishes to increase participation on the Junior Level; and


**Whereas**, the Honorary Junior Auxiliary Meeting is currently held at the Department Convention in April each year; and

**Whereas**, attendance at the Annual Meeting has been low due to inability to attend because it is held during the school year;

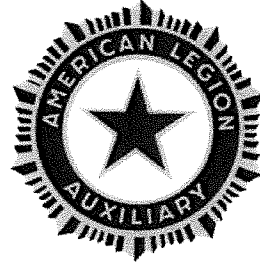




**Whereas**, the revenue of the American Legion Auxiliary, Department of Alaska is derived from the annual membership dues of its members; and




**Whereas**, the costs of conducting business of the American Legion Auxiliary, Department of Alaska have increased; and



**Whereas**, the revenue of the American Legion Auxiliary, Department of Alaska is derived from the annual membership dues of its members; and




**Whereas**, the costs of conducting business of the American Legion Auxiliary, Department of Alaska have increased; and

Department Convention; and


**Whereas**, when the Conference is held in September, the hotel costs are under summer rates;



that the Fall Conference be held the third (3<sup>rd</sup>) weekend of October; and


